

CKenergy Electric Cooperative, Inc is requesting a Statement of Qualification (SOQ) and bids for design and staking related to the ice storm damage to the electric distribution system in **Caddo**, **Canadian**, and **Grady** Counties OK (November, 26 2020). Project 173830 consists of **94.010** miles (**61.340** Single Phase, **6.020** V Phase, and **26.650** Three Phase).

Design and Staking

- A. Design and Stake ahead of line contractors. Construction work based on this staking work will likely extend continuously over multiple years. Staking work will be completed in sufficient time to stay ahead of Line Contactors to ensure steady and efficient work flow. The staking work will include retirement, new design and field staking of single phase, V-phase and three phases.
- B. Design and Staking shall be conducted utilizing current CKenergy design standards.
- C. Retirement, New Design, Field Staking and posting shall be completed utilizing FUTURA STAKING (Note the existing data will need to be inventoried before it can be retired)
- D. Contractor shall be familiar with both SEDC and FUTURA products and will also be responsible for coordinating with FUTURA and CKenergy to set up VPN access and FUTURA user account.
- E. Contractor will be responsible for providing computers and their own IT support.
- F. Contractor shall be responsible for providing electronic staking sheets and materials generated with **FUTURA STAKING**
 - Contractor shall be familiar with CKenergy construction units.
- G. Total miles could be reduced or increased with no change to unit cost bids.
- H. Unit costs shall include all travel, lodging, meals, fuel, equipment, construction stakes, retirement, new design, field staking, and any miscellaneous costs associated with meetings, review or other items.
- I. DART rate and OSHA 300 log shall be submitted with bid package.
- J. A copy of Commercial General Liability Insurance Policy shall be submitted with Bid package.
- K. **Bidders awarded work** will be required to submit a copy of Commercial General Liability
 - Insurance Policy with CKenergy as additional insured before work begins.
- L. **Bidders awarded work shall be required to have or obtain**; liability insurance covering operations of not less than \$2 million each occurrence, property damage not less than \$2 million each occurrence, and \$2 million aggregate for accidents; liability auto insurance covering \$2 million per person, \$2 million each occurrence, and \$2 million property damage each occurrence.

To receive consideration, the SOQ must be developed and submitted within these parameters:

- 1. The SOQ is limited to 10 pages, excluding resumes;
- 2. Submit five (5) hard copies and one electronic PDF copy of the SOQ;
- 3. The SOQ document and package label must be clearly marked "Statement of Qualifications for Professional Services for Electric Distribution Mitigation";
- 4. The SOQ must include the proposer's contact information.

Award of contract will be based on:

- 1. Qualifications, bid price, project understanding, workflow and procedures for mapping, documenting and evaluating circuits.
- 2. Familiarity with RUS construction standards and FUTURA software;
- 3. Specialized experience and technical competence of the firm with respect to lineman whom will be in the field evaluating the system;
- 4. The capacity and capability of the firm to complete all work necessary for completion within 90 days of signing the contract;
- 5. Past performance and references of the firm.

CKenergy reserves the right to reject any and all proposals and to select a firm and award a contract that is deemed to be in the best interest of the utility.
